- Voter registration closes at the end of the business day on Tuesday October 14, 2025.

Notice of ballot audit

In compliance with the provisions K.S.A. 25-3009 after an election and prior to the meeting of the county board of canvassers to certify the official election results for any election in which the

canvassers certify results, the county election officer shall conduct a manual audit or tally of each vote cast, regardless of the method of voting, in 1% of all the precincts with a minimum of one precinct located within the county. The precinct or precincts shall be randomly selected, and selections shall take place after the election. The audit will take place November 6th @ 4p.m in the Osage County Clerk's office.
